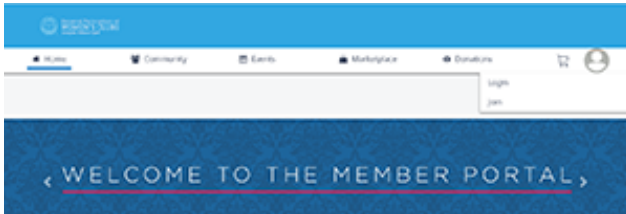

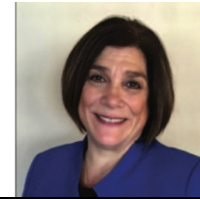

## Standing Rule Amendments

### 1. Article IV. OFFICERS

Section 3. Eligibility: Candidates for office shall:

b. Insert "First" before "have." Strike "at least one term on the GFWC Board of Directors" after "served" and before "as" and insert after "President," the words "if no candidate is available, then second would be a Past State Director of Junior Clubs and third would be a Past State Officer. If there are no candidates from that State, then a candidate from one of the other states, not represented, may be considered following Article IV. Section 9. Vacancies."

If adopted would read:

b. *First* have served as a State President, *if no candidate is available, then second would be a Past State Director of Junior Clubs and third would be a Past State Officer. If there are no candidates from that State, then a candidate from one of the other states, not represented, may be considered following Article IV. Section 9. Vacancies.*

Rational: To broaden the list of qualified candidates who may not have served on the GFWC Board.

### 2. Article V. MEETINGS

Section 4. Insert at the end of the first paragraph a subsection:

*"The quorum for the semi-annual meeting shall be ten ( 10 ) members with representation from at least four (4) of the six (6) New England States."*

If adopted would read:

4. A semi-annual meeting shall be held during the GFWC Convention at which time the agenda shall include, in the even-numbered year, the installation of Region officers. The semi-annual meeting will be scheduled by the GFWC President.

*The quorum for the semi-annual meeting shall be ten ( 10 ) members with representation from at least four (4) of the six (6) New England States.*

Rational: To specify a quorum to allow for voting , if necessary, at this meeting.

### 3. Article VI. DUTIES OF OFFICERS

Section 4. The Secretary

Re-letter "c" to "b" and "d" to "c".

b. Insert "of" between "and" and "the semi-annual". Insert in this section after the word "minutes" before "within" in the last sentence the words "electronically, for electronic signatures,"

If adopted would read:

b. She shall record the minutes of all meetings of the GFWC New England Region, of the Board of Directors meetings and *of* the semi-annual meeting held during the GFWC Convention. She shall submit minutes to the President and committee members appointed for approval of the minutes *electronically, for electronic signatures*, within three (3) weeks after each meeting.



Rational: To update to electronic signatures.

#### 4. Article IX. STANDING COMMITTEES

2. A NOMINATING COMMITTEE Strike "four (4) and insert six (6) after "of" and before "members" and strike "not more than" between "members" and "one". Put a period after "elected" and strike the rest of the sentence.

If adopted would read:

2. A NOMINATING COMMITTEE of *six (6)* members (one from each state) shall be elected. The committee shall be elected at the Conference in the even-numbered years and, immediately following election, the committee shall elect its Chairman.

Proviso: if adopted, would go into effect for the 2022-2024 administration

Rational: To allow for a member from each state to participate if a new officer needs to be selected.

#### 5. Article X. FINANCES

7. Strike the following "eight hundred and fifty dollars (\$850) after "sum of" and before "by" and insert "nine hundred dollars (\$900)". Insert period after "Treasurer" and strike "from the receipts of registration." after "Treasurer." The second paragraph to remain unchanged.

If adopted would read:

7. The hostess state federation shall be reimbursed the sum of *nine hundred dollars (\$900)* by the GFWC New England Region Treasurer.

The hostess state shall provide a complete report for Region records with a copy for the next hostess state's reference.

Rational: To conform to the approved budget. Since we pay out of budget we do not need to say where the money came from.

6. Re-number Article XIV. REDISTRICTING AND/OR DISSOLUTION CLAUSE to Article XV: Of the same name.

#### Insert a new Article XIV. EMERGENCIES

If adopted would read:

*"In the case of a national emergency, state emergency, or any type of event (man-made or natural) that could potentially put members in danger, the GFWC New England Region President, with the consent of the majority of the GFWC New England Region Board of Directors, may hold electronic meetings. If necessary, any important business for those meetings will be sent by mail prior to the meeting. The information will be sent to each state president who will send it out to all state clubs. The clubs will return any votes to the NER President and copy State President by mail by the designated deadline. Each club will be entitled to as many votes as the number of delegates it is allotted when a convention is held."*

Rational: To allow for electronic meetings if necessary and to allow for voting by the usual form of communication for the states. Since this proposal says that a ballot will be *sent* to each club, that would

allow emailing the ballot if the clubs in your state, or the members of your club, communicate by email. Otherwise, the ballot must be sent by USPS mail.
